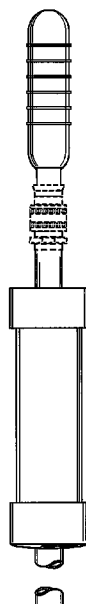

DESCRIPTION

FIG. 1 is a side elevational view of a drain clearing kit showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is an enlarged front elevational view of FIG. 2; and,
FIG. 5 is an enlarged rear elevational view of FIG. 3.
The bottom portion of the drain clearing kit is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.
The broken line showing of details in FIGS. 1, 2 and 4 is included for the purpose of showing environmental portions of the drain clearing kit and forms no part of the claimed design.

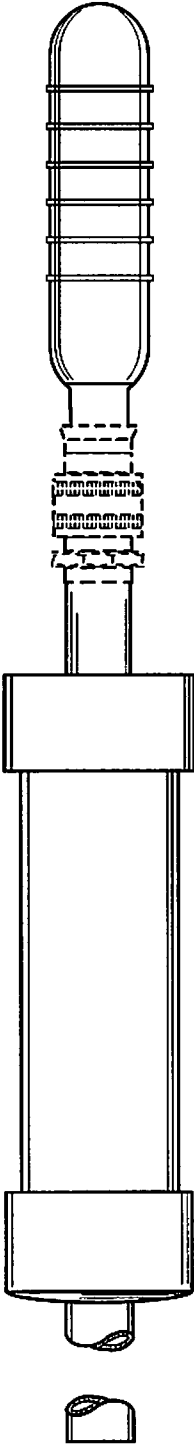

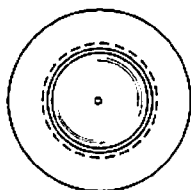

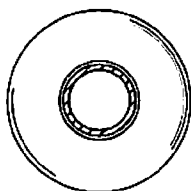

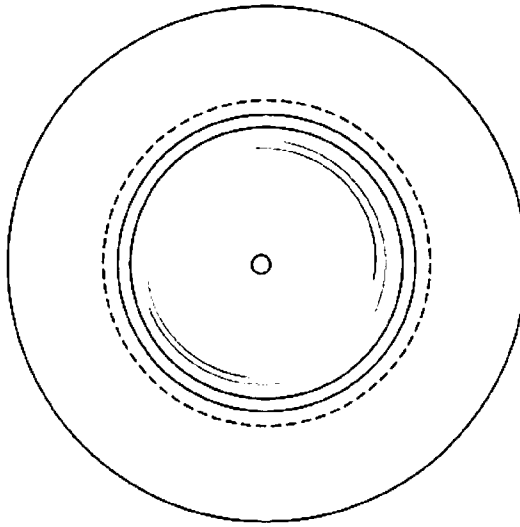
